- 1. I am not a citizen of the United States and I do not reside in the United States. I do not have a contractual relationship with the AOL Foundation of the United States (Plaintiff).
- 2. Under the pseudonyms Klim and AOL-Free, I am the creator of the "Leaving the Art of Living" ("LAOL") Blog, hosted on Google's "Blogger" platform at (www.artoflivingfree.blogspot.com). The Blogger platform enables other persons to author 'comments" on the LAOL Blog, I have also posted articles authored by others, which bear pseudonyms other than "Klim," which were submitted to me for publication on the LAOL Blog. Of the specific statements placed at issue in the Complaint, I am the author only of articles or comments bearing the pseudonyms "Klim," and of the comment bearing the pseudonym "Klim & Co." (although I am not the author of all comments bearing the pseudonym "Klim & Co."). In other words, of statements on the LAOL blog, I am only the author of statements A, B, D, E, I, and R but not of comments M, N, or P. The Blogger software automatically affixes "Posted by AoL Free" to articles that I post to the Blog. With respect to the articles and statements at issue here, where an article does not bear a pseudonymous author but indicates that it was posted by "Aol-Free," it was authored by me, but where it bears another pseudonym such as JOSH or NICK, it was authored by a third party who forwarded the article to me for publication on the LAOL Blog. I am not the author of any of the statements at issue on the BAOL blog. Nor did I post any of the allegedly trade secret or copyrighted materials, all of which were posted on the BAOL blog, not on my LAOL blog.
- 3. I am very concerned that the disclosure of my identity would expose me and my families to harassment and retaliation by loyal adherents of Ravi Shankar. I am concerned that disclosure of my identity would set a precedent that would make others fearful that if they honestly voiced their opinions concerning Shankar and/or AOL, they too would face such harassment and retaliation. AOL adherents have widely circulated statements by an AOL Swami (i.e. a person high up in the AOL hierarchy) denouncing dissidents, which identified dissidents, including, in one example the person's name and country, as well as the names and contact information for (purported) ex-boyfriends and associates that could testify that the dissident in question was mentally unstable, true and correct copies of which are attached as Exhibit G1 to the Request for Judicial Notice.
