1 I, _____ [name redacted], declare as follows:

2 1. I am the registrant and user of the email address
3 "aurorapartners@gmail.com" (the "Email Address"). Unless otherwise stated I have
4 personal knowledge of the matters stated herein.

5 2. I have appeared anonymously in this action to file a motion to quash the
6 United States of America Securities and Exchange Commission ("SEC")'s subpoena to
7 Google, Inc., which seeks to reveal the identity of the registrant of the Email Address (the
8 "Subpoena").

9 3. I use the Email Address to speak anonymously on the Internet.
10 Specifically, I use the Email Address to post my opinions on various political blogs,
11 including about the policies of specific members of the U.S. Congress. I have made
12 these political statements under the belief that my anonymity will be protected.

13 4. The SEC did not notify me of the Subpoena either before or after it was
14 served on Google. I check the inbox for the Email Address regularly, and would have
15 learned if the SEC had tried to notify of the Subpoena by email.

16 5. On July 19, 2011 Google sent me an email notifying met of the Subpoena.
17 A true and correct copy of that email is attached hereto as Exhibit A.

18 6. Upon learning of the subpoena, I engaged counsel to communicate with the
19 SEC and file a motion to quash the Subpoena if necessary.

20 I declare under penalty of perjury under the laws of the United States of America
21 and the State of California that the foregoing is true and correct and that this Declaration
22 was executed on August 4, 2011.

25 *have redacted identifying information herein to avoid prejudice to the right of the*
26 *Declarant to anonymity.*


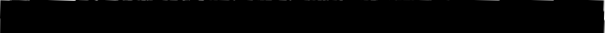
